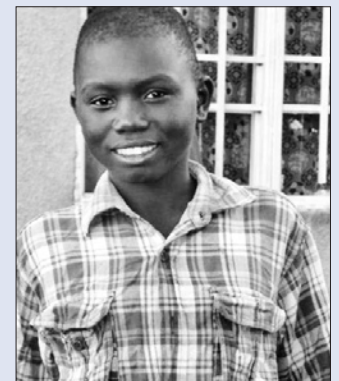

# BAJA 1000 RACE

**W**hen is the last time you drove your car at 180 miles per hour across the scorching, dusty desert? Every year in the fall, hundreds of hard-core off-road enthusiasts gather in front of tens-of-thousands of fans to see who's the fastest across 1,036 miles of raw, untamed desert between Ensenada and La Paz on Mexico's Baja Peninsula.

For two days prior to the start of the event the race teams gather in Ensenada, Mexico to prepare for the running of the most famous off-road endurance race in North America. Fans are allowed to wander the streets of Ensenada looking at the race vehicles and visiting hundreds of vendor booths set up along the 'street' section of the course.

ICC was able to have a vendor booth at this year's Baja 1000 due to the generosity of Malcolm and Joyce Smith and SCORE



International. Malcolm and Joyce Smith, through Malcolm Smith Motorsports, have been the premiere suppliers of off-road gear for off-road enthusiasts since 1970. SCORE International is the sanctioning body for the Baja 1000 under the direction of Sal Fish.

Malcolm and Joyce Smith administer the Malcolm Smith Motorsports Foundation which has been a big supporter of ICC's El Oasis Children's Village in Baja, Mexico. The Smith's especially support our educational needs at El Oasis. At the press event for the race teams on

the day before the race, ICC's Doug Congleton presented a plaque to Sal Fish, director of SCORE International, in honor of his efforts on behalf of ICC and El Oasis.

Our vendor booth at the Baja 1000 sold items generously donated by Malcolm Smith Motorsports. The proceeds from the sales supported our educational needs at El Oasis. SCORE International donated the space for the booth. The booth was manned by Doug Congleton, ICC's executive director and Daniel Ixcot, ICC's development director in Mexico.

# A Personal Note

Dear ICC Family,

“Did you know there are some abandoned children at the jail here in Alajuela?” a friend told me one day. She knew that I had a special interest in orphaned and abandoned children. I had visited the large government orphanage in nearby San Jose, but I had never heard of keeping children at a jail.

It wasn't far to the jail from the Adventist University in Costa Rica where we lived. Ken was helping to organize a much-needed industry for the students. The next day I found my way to the jail where the children were sitting on some rough benches in a room near the entrance. I couldn't imagine why they would be there so I found the matron of the jail and inquired, “What are those children doing here?”



“Well, I've been told that they were found alone, sleeping under a tree,” she answered. “I think the social worker is trying to find out who they belong to before putting them in the orphanage in San Jose.”

I wondered what facilities for children they would have in a jail. They looked so frightened and dejected, just sitting there together. “Could I speak to the social worker?” I asked.

“I'll see if she is available,” she answered, and soon another younger woman came. “Can I help you?” She asked.

“I'm interested in knowing about these children. Why are they here?”

She verified the other woman's story, but wondered who I was. Seeing that I was an American, why was I interested?

“Well, I am a pastor's wife and have a special interest in abandoned children. I have been able to help some homeless children.”

She became interested and told me that she would appreciate any help I could give. “First of all we have to see if we can locate their mother or a relative. However, they have been here a few days, and we haven't found any clue as to who they are.”

“I'll come back in a day or two,” I told her.

I told Ken about the children, and, knowing me, he knew I would follow up on what happened to them. That night I couldn't get to sleep thinking about them. Where would they sleep and what would they get to eat? Jails don't provide the right food for little children.

The next morning I went back and asked to talk to the social worker again. “Would you let me take them to my house for the day?” I asked her.

“I think that would be great for them. There is nothing for them to do here or any place for them to play. I'll ask them if they want to go.” The oldest boy was eight, the next a girl, seven, another girl, five, and a little boy three.

To see the smiles on their faces and their eyes lighting up, there was no question of what they wanted to do. Coming into our house, I let them feel free in our living room while I went to the kitchen to make a meal for them. I wished I had some toys but I didn't. The oldest of the group, Luis, told me he



had been to school and could read. The only book I had in Spanish was Steps to Christ, so I gave it to him and he immediately sat down to read it. I learned later that He read it over and over.

When dinner was ready I helped wash them up and set them around the table, just like I would any guest. They were awed, I'm sure, but their manners were amazing, considering that they probably were sitting up to a table for the first time. It was obvious that Luis had learned to care for his siblings. It was also obvious that they were really hungry, not only the way they dived into their food but they were thin and pale. I sat at the head of the table with them, and about that time Ken walked in.

"Well! What do we have here?" he asked with a big smile. He wasn't surprised, knowing that he might find an extra child or two at our house any time.

"We have company," I responded and introduced each child to Papi Fleck. I put another plate at the end of the table, and from then on Ken took over making them feel very welcome. When they had eaten all they could hold, Ken spent the rest of the day playing with them. I heard a lot of excitement in the living room. At one point Ken was at the piano playing a lively march and the children were marching around the room, having a ball.

We hated to take them back to the jail, but we let them know we would see them again.
